• A Electronic Slaughter Tag can be applied if an animal is intended for slaughter in the UK before 12 months of age.

All Tup Lambs are to be declared and sold separately.

Vendors are advised to Scab Dip or Treat animals with a DEFRA approved product

SHEEP MEDICINES:- Vendors must advise at the time of sale if any of their animals are still within a withdrawal period for any medicines.

Please have the full address (including postcode) & holding number for the destination of the sheep purchased when collecting your invoice and movement license.
