VENDORS

Vendors of Dairy Cattle will now be allowed to attend the sale and represent their stock. However, this will be subject to **STRICT 2 metre social distancing** being adhered to which will be monitored by the local authority and in the event of non-compliance, the auction mart's licence to operate could be suspended. The protocol listed on the website must be followed.

** PURCHASERS **

You will be required to register at the sale ring entrance prior to the sale.

Pre-sale viewing of cattle will be allowed subject to social distancing being maintained.

During the sale social distancing must be strictly adhered to and purchasers will be required to stand/sit at the positions marked with blue tape at ring side or seating areas.

VENDORS- COVID-19 PROTOCOL

- a) One vendor to attend per consignment i.e no extra family members or onlookers
- b) Prior to sale, vendors may wash their cattle and stand by their animal(s) but must respect social distancing
- c) Vendors to follow their stock to the ring and represent their animals in the usual manner
- d) Following the sale of their stock, vendors to leave the sale ring (i.e. not to remain to watch other stock being sold, liaise with buyers)
- e) Luck money etc to be sorted by the auction staff as has recently been the case
- f) Vendors at all times to maintain 2 metre social distancing

Any instructions regarding luck and reserves, if any, along with as much information as possible with regards to your entries, should be given to the auctioneers/clerk in writing prior to the sale.
