VENDORS-COVID-19 PROTOCOL

- a) Two vendors may attend per consignment but only one to show cattle through the ring i.e no extra family members or onlookers
- b) Prior to sale, vendors may wash their cattle and stand by their animal(s) but must respect social distancing
- c) Vendors to follow their stock to the ring and represent their animals in the usual manner
- d) Following the sale of their stock, vendors to leave the sale ring (i.e. not to remain to watch other stock being sold, liaise with buyers)
- e) Luck money etc to be sorted by the auction staff as has recently been the case
- f) Vendors at all times to maintain 2 metre social distancing

Any instructions regarding luck and reserves, if any, along with as much information as possible with regards to your entries, should be given to the auctioneers/clerk in writing prior to the sale.



Please be prepared and bring a facemask. They are compulsory throughout the Auction Mart
