Vendors presenting cattle in the market that have not had a clear TB test are liable to prosecution. Bentham Auction Mart will take no responsibility for ineligible cattle entering the market and the vendor indemnifies the auction mart and its staff from any consequential loss claims.**

**WARNING:** The making of a false declaration or the supply of an animal which is accompanied by a false declaration may constitute an offence under section 1 of the trade descriptions act 1968, for which the maximum penalty on summary conviction is a fine not exceeding £5000 and a conviction on indictment, a fine or imprisonment for a term not exceeding two years or both.
